

# ACRA BizFin<sup>x</sup> Preparation Tool

## Preparing and Filing XBRL Financial Statements



**BizFin<sup>x</sup> Preparation Tool** is a new preparation tool which enables companies to prepare their financial statements in XBRL offline. XBRL financial statements can be prepared and managed on MS Excel-based templates in the minimum requirement list. To reduce the time taken for manual data entry, the tool is equipped with an auto-tagging function to auto-map items and a drag-and-drop functionality to populate the financial data.

This one-day training course will include an overview of the tool and provide interactive hands-on training of using the ACRA BizFin<sup>x</sup> preparation tool.
